FOR YEAR ENDING 31st MARCH 2016

Structure, Governance & Management

The Clinical Human Factors Group is an independent campaign group managed by a board of Trustees, which aims to stimulate dialogue and demonstrates through concrete action how a better understanding of the role of human factors can have a significant impact on safety, quality and productivity of health.

Trustees are appointed at the Annual General Meeting of the Clinical Human Factors Group. Trustees retire from office at this meeting by rotation based on length of service as trustees. Trustees who have retired can be reappointed if the vacancy has not been filled.

The board of trustees consist of healthcare professionals, managers, service users, services experts.

The Trustees operate under its Charity Trust Deed.

Objectives and Activities - Public benefit

The Clinical Human Factors Group will work for the advancement of education among Healthcare Staff (including managers, policy makers and allied hospital staff) of Clinical Human Factors so as to directly preserve and protect public health.

The Trustees of Clinical Human Factors Group present their report for year ending 31st March 2016.

Achievements and Performance

CHFG has remained true to its mission of promoting an understanding of human factors in healthcare and holding the system to account for its actions in respect of this vision.

Our work has continued around our three manifesto goals; i) promoting human factors education and training, ii) building high reliability organisations and iii) promoting intelligent regulation and independent investigation.

We ran a successful Open Seminar in Birmingham and a healthcare- focussed Human Factors conference in Manchester. The CHFG website www.chfg.org was updated and maintained as a source of information and contacts. CHFG members were kept in touch with developments in human factors in healthcare via E-newsletters and blogs.

CHFG have worked on a regular basis with a number of politicians including, for the last two years, the Secretary of State for Health and helped design and prepare policies around developing a learning and just culture in the NHS (announced in March 2016). We produced a new resource "Human Factors in Healthcare; common terms" which explains the terminology used in the science of Human Factors and Ergonomics and how it relates to everyday practice in healthcare.

We influenced the 2015 Parliamentary Admin Select Committee Inquiry into Complaints and Failure in the NHS to include a focus on the role of independent investigation and gave evidence to two reviews on this topic in 2015

We have continued to spread knowledge regarding the potential of incorporating human factors in healthcare through dissemination of the CHFG "What good looks like" publication

Reserves Policy
